### A Letter from Our President

It's been a great year for the Hilltown Land Trust. Below are some of our accomplishments.

**New Farm Conservation Restrictions:** As you may have seen in The Daily Hampshire Gazette and Country Journal on December 27, we closed two conservation restrictions in Worthington: the 86-acre farm on Kinne Brook Road owned by Toni Lake and the adjoining 166-acre farm on Patterson Road owned by Paul Strasburg. (See article below.) These properties link—through Hattie Plehn's West Street farm, on which we also hold a conservation restriction—to the state's Fox Den Wildlife Management Area Together, they will establish a wildlife corridor from Kinne Brook Road west into Middlefield. These donated conservation restrictions are truly gifts to the planet, which needs every bit of help it can get. And there are more CRs in the works—to be announced when they are completed.

New Grant, New Database, New Staff: We are beginning to outgrow our traditional ways. We've received a \$9650 grant from the Massachusetts Land Trust Coalition, funded by the Kohlburg Foundation, to help us build a web-based informational database to manage our CRs (23 to date) and owned land (6 parcels totaling 597 acres) as well as manage the expected transition in 2009 from an all-volunteer land trust to one with staff—one part-time and surely overworked executive director. But not a small change and we will have to adapt how we work to the new reality. Actually, we're all pretty excited. We'll start the search for the director early next year.

## Two Farms Saved in Worthington

The Hilltown Land Trust **1** announces the completion of its acquisition of Conservation Restrictions on two Worthington farms, bordering on Kinne Brook and Patterson Roads and West Street, totaling more than 250 acres. "These two beautiful and contiguous farms, among the last in the Kinne Brook Valley section of Worthington, will be preserved substantially in their present condition, available for farming and forestry indefinitely into the future," says Wil Hastings, President of the land trust.

The Conservation Restrictions were donated to the Hilltown
Land Trust by the current owners of the farms, Antonia Lake and Paul Strasburg, and will provide a contiguous wildlife habitat stretching west from Worthington's Kinne Brook Road into the Fox Den Wildlife Management Area held by the state's Department of Fisheries and Wildlife in Worthington and Middlefield.

"Central to these gifts," says Wil, "is the protection of a significant portion of the Kinne

Brook itself, a major cold-water tributary of the Middle Branch of the Federally-designated 'Wild and Scenic' Westfield River. These are gifts to the planet, for which we are very grateful."

As these are charitable contributions, the owners will be entitled to deductions from their federally-taxed income for the value of these gifts. Because the farms are already enrolled in the state's current land-use programs under Chapters 61 and 61A, no reduction in the real estate taxes for these properties is expected. •


## New HLT Walking Trail in Huntington

The Hilltown Land Trust is **■** delighted to announce the opening of a new 1.2-mile walking trail on part of the 379-acre property donated to the HLT by Frank Stevens on Pisgah Road in Huntington. This beautiful trail winds through a wooded landscape studded with hundreds of large boulders covered in mosses, ferns and lichens. It passes a very early cellar hole and maple sugarhouse ruin, climbs up and down steep slopes, and crosses a moist stream valley in three places. Expect lots of early spring wildflowers and a great variety of ferns, and look for signs of moose, deer, bear, coyote, porcupine, and many other mammals.

Newly cleared in the fall of 2007, much of the trail is not yet "worn in," and fallen leaves may hide small obstacles underfoot. Watch your step. The trail is

marked with survey flagging, to be replaced ASAP with paint blazes.

In winter, the trail is snowshoeable in deep soft snow, but hazardous when conditions are slippery; avoid it then. The trail is not suitable for X-C skiing or biking at any time, and all motorized vehicles are prohibited. **Driving Directions to the Stevens Trail:** At the highest point on Route 66, 0.4 mile West of the Westhampton-Huntington town line, turn North off Route 66 onto Allen Coit Road. Go 0.4 mile to the intersection with Pisgah Road and bear Right onto Pisgah. Go 2.4 mile North from that intersection to HLT's unmarked parking pullout and small clearing at break in stone wall on the Right. Trail leaves the North side of the clearing, heading first slightly downhill and soon turning Right **Eric Weber** and uphill.



# Celebrating Our CR Landowners

This past September the Hilltown Land Trust held its first dinner to officially honor landowners for placing their land in a Conservation Restriction (CR) with the HLT. Appropriately, the event was hosted by HLT treasurer Ruth Pardoe and her husband David at their farm in Huntington, which was the first CR the HLT undertook almost 20 years ago.

Wil Hastings, president of the HLT, aptly characterized our CR landowners as "local heroes." Thanking them for their generosity, foresight, and trust in the HLT, he said, "It's an incredible transition from owning your property to placing it in permanent conservation."

Of course, the conversation at any event at which HLT board members and landowners get together will inevitably focus on land conservation. At this dinner, the topic was how the HLT can continue its work most effectively. Some suggestions offered by landowners included educating the public and elected officials about the tax and financial benefits of land conservation, encouraging neighborto-neighbor meetings to identify land that should be preserved and discussing ways to do that, town by town, and reaching out to the next generation of landowners, such as the children of our CR landowners and residents who have recently bought land in the hilltowns.
